## SPECIAL ORDERS

- Bridal, Bridesmaid or Special Occasion dresses SHOULD be ordered TO ARRIVE minimum of 3 weeks in advance of the event. UPS upgrades are available for an additional cost. I understand a rush charge for bridesmaid or informal dresses will run \$25 to \$100 each. You will be notified before order is placed if rush charge applies. **Ship dates given are approximate, therefore they cannot be guaranteed.** (\_\_\_\_)
- Dye lots cannot be guaranteed. This is due to **shade, style and fabric** variations within the same manufacturer or when ordering from multiple manufacturers. (\_\_\_\_)
- \*\* When BASIC ALTERATIONS are included in the price, it is recommended to schedule appointments as soon as your dress arrives if it is close to the event date. Otherwise appointments are subject to availability and made to accommodate your schedule and the seamstress. (\_\_\_\_) Keep in mind all special additional alterations will have an additional charge, which will be discussed at the time of your fitting. (\_\_\_\_)
- **50% of original price is due upon ordering, the balance is due upon notification of the garments arrival. I understand there will be a \$50 late fee per month if dress or dresses are not paid within 10 days of when the dress(s) arrive.** (\_\_\_\_)  
\*\*When ordering a group (2 or more) Bridesmaid Dresses there will be a \$10.50 shipping fee for each dress. (\_\_\_\_) A single dress ordered will have a \$19.75 shipping fee. (\_\_\_\_)
- \*\*Returned checks and checks that have had the payment "stopped" are considered non-payment, and all orders will be halted until another method of payment has been made. A \$35 service fee will be charged. (\_\_\_\_)
- \*\*If payment has been canceled after the removal of the garment (s) from these premises, civil or criminal legal actions may result. Buyer assumes the responsibility for any legal fees that result from this action. (\_\_\_\_)
- \*\*Phone orders will require a Credit Card Authorization to be filled out and signed. (\_\_\_\_)

\*\*All merchandise leaving the store with balance due must be paid for in full with credit card or cash. (\_\_\_\_)

- \*\* I have received a copy of the basic alteration and understand what is covered in my price. (\_\_\_\_)
